

## Yare Valley Society Annual General Meeting

The AGM of the Yare Valley Society will be held on 24th May 1993, at the Cringleford Playing Field Pavilion, entrance from Oakfields Drive. Please come along to support us. The meeting will start at 7.30pm.

The speaker after the meeting will be John Ayton, recently retired Head of Planning at Norfolk County Council. His talk, entitled 'The Changing Pattern of Development around Norwich - Who is to Blame and Why?' will be illustrated with slides. We are very lucky to have him come to talk to us and I am sure you will have lots of questions for him.

### The Norfolk Structure Plan to 2006

The Secretary of State for the Environment made his final modifications to this Plan in March. The strong representations made by the County Council and many hundreds of Norfolk people persuaded him to reduce his proposed overall housing figure by 3000 and to reinstate some environmental safeguards. However only one quarter of the policies still remain as originally submitted.

Sadly, all Green Belt policies for the Norwich area have been removed, but policy N8, which seeks to protect the Yare Valley, has been retained though slightly modified.

#### AGR Windows

The enforcement notice date for removal of the portacabins has been extended to 1 May by South Norfolk District Council, with the cabins having to be off the site by 1 June.

South Norfolk Local Plan for the Norwich area Final modifications for further public comment will not be available until June or July.

As you will probbly know, planning permission has been refused by
Norfolk County Council.

# More Building Plans by UEA

If you're unimpressed by the architecture of the new buildings at UEA, you will be disturbed by a new proposal to redevelop part of the site the University used to occupy on the corner of Earlham Road and Wilberforce Road. The ground is next to St Mary's Church, Earlham, and overlooks both the river and Earlham Park. We have studied the plans and are objecting strongly to the proposal to build accommodation for over 800 students in the 124 flats (some 4 stories high) and 28 houses.

This very high-density building would be quite out of keeping on this site. Also there are serious potential traffic hazards from large numbers of additional students crossing the Earlham Road.
